




Getting Started in HeinOnline Quick Reference Guide

Logging In: From the <u>HeinOnline</u> <u>homepage</u>, click either of the Login buttons located at the top of the page.

Welcome Page: View subscribed collections by both category and name. Perform a full text search, search for a document by citation, and access the HeinOnline catalog or case law. Click search help for quick tips on searching in HeinOnline.

Click the more information link next to any collection to see a brief description of the collection's content or to download a full list of available titles.

Full Text Search

The search bar is stationary and available on all pages in HeinOnline. Perform a quick text and metadata search using the Full Text search option. Clicking *Advanced Search* will expand options to include up to six advanced search fields. Users can also select specific titles and a year range to narrow search parameters even further.

Search the Catalog


